Notices of the meeting place were timely posted at a site readily accessible to the general public at all times and remained posted for at least seventy-two hours preceding the scheduled time of this meeting, in compliance with the Open Meetings Act.

WHEREAS, the 2022 Texas Department of Housing & Community Affairs Community Resiliency Program Fund requires implementation by professionals experienced in the implementation of managing grant funds to CDBG requirements;

WHEREAS, in order to identify the most qualified provider for these services a Solicitation for Grant Writing, Application Preparation and Grant Administration Services Request for Proposals has been completed in accordance with CDBG 24 CFR 200 Guidelines and Texas Department of Housing & Community Affairs requirements;

WHEREAS, the proposals received by the due date of November 23, 2021 10:00 AM have been reviewed and evaluated resulting in the identification of the most qualified, responsive provider for this service;

Section 1. That Fore + Company Consulting be awarded a contract to provide Texas Department of Housing & Community Affairs Community Resiliency Program project-related grant writing, application preparation and professional administration/management services for the Terrell County 2022 TDHCA Community Resiliency Program Fund;

Proposals for Grant Writing/Application Preparation and Grant Administration for TDHCA Community Resiliency Program – No Action.

Schedule Public Hearing for TDHCA for December 20, 2021, at 5:00 p.m. – Commissioner Sanchez motioned to have the Public Hearing for TDHCA on December 20, 2021, at 5:00 p.m. in the Commissioners Courtroom. Commissioner Johnson seconded the motion calling for a vote; all members answered "aye," and the motion carried.

Colonial Fund Construction Application approved for one million dollars – Two-year contract starting February 1, 2022, through December 31, 2024. No Action.

Prohibit Sales or Use of Restricted Fireworks in Terrell County for the Period of December 26, 2021, through January 1, 2022 – Commissioner Johnson motioned to prohibit the use of airborne fireworks from December 26, 2021, through January 1, 2022. Commissioner Sanchez seconded the motion calling for a vote; all members answered "aye," and the motion carried.

ORDER PROHIBITING CERTAIN FIREWORKS IN UNINCORPORATED AREAS OF TERRELL COUNTY, TEXAS

WHEREAS, the Commissioners Court of Terrell County has determined that the normal danger of fire in the unincorporated areas of Terrell County is greatly enhanced by the extremely dry conditions now existing;

NOW, THEREFORE, the Commissioners Court of Terrell County adopts this Order prohibiting the sale or use of restricted fireworks in the unincorporated areas of Terrell County beginning December 20, 2021-Midnight, January 1, 2022.

- A. A person may not sell, detonate, ignite, or in any way use fireworks classified as "skyrockets with sticks" under 49 C.F.R. part. 173.100(r)(2)(10-01-86 edition) or missiles with fins in any portion of the unincorporated areas of Terrell County.
- B. This order does not prohibit "permissible fireworks" as authorized in Occupations Code Section 2154.003(a).
- C. A Person commits an offence if the person knowingly or intentionally violates a prohibition established by this order. An offense under this order is a Class C. Misdemeanor.

Approval of payment for only the Basic Services for the Indigent Program for the year 2022 – Commissioner Gully motioned to approve the Basic Services for the Indigent Program for the year 2022. Commissioner Johnson seconded the motion calling for a vote; all members answered "aye," and the motion carried.

Terrell County Indigent Health Care Eligibility Standards

December 2021 –During the 2021-22 fiscal year, Terrell County, Texas will use the following rules and procedures to comply with its state-mandated responsibility under the Indigent Health Care and Treatment Act. The Indigent Health Care and Treatment Act is an attempt to address the needs of indigent Texas residents who do not qualify for other health care assistance programs.

Eligibility determinations will be based on residency, income, household composition, and resources. Qualified applicant income will not exceed the amount specified on the gross monthly screening table located in the County Indigent Health Care Program Manual at 21% of the Federal Poverty level.

An application form for the program may be obtained at the Terrell County Judge's Office in the Terrell County Courthouse in Sanderson, Texas. Eligibility determination will be made within 14 (fourteen) business days after the date a completed application and all required documentation is received by Terrell County Indigent Health Care Program in the County Judge's office.

Terrell County authorizes the County Judge to negotiate rates with pharmacies that may be greater than state guidelines. Otherwise, Terrell County does not authorize any optional services or payments exceeding the minimum requirements set by the Texas Department of State Health Services. Terrell County will use rules and procedures found in the County Indigent Health Care Handbook which is published by the Texas Department of State Health Services. Terrell County Commissioners Court reserves the right to reevaluate the payment method at any time; all parties will be notified if payment method changes.

Terrell County does not discriminate on the basis of age, race, or gender in administering the Indigent Health Care Program. Applicants have the right to appeal adverse decisions regarding eligibility.

Pursuant to Health and Safety Code Section 61.030, Terrell County has designated Sanderson Rural Health Clinic and Pecos County Memorial Hospital as the mandated providers for indigent health care services except under the following circumstances:

- 1. in an emergency;
- 2. when medically inappropriate; or
- 3. when care is not available.

Terrell County has no financial responsibility for non-emergency services rendered to eligible residents by non-mandated providers.
