

The projects must benefit or be available to an entire community and must improve the value of a capital asset by building, renovating or purchasing equipment.


Applicants requesting more than \$5,000 in grant funding must supply matching funds of at least 20 percent of the total project cost. Grants larger than \$25,000 are intended for particularly impressive and noteworthy projects with a far-reaching impact on a broad community. The larger grant category is extremely competitive, as funding in the \$25,000+ category is limited to 30 percent of the grants awarded. There is a minimum request of \$1,000.

JURY SELECTION PLAN TERRELL COUNTY

STATUTORY AUTHORITY

This plan shall be in compliance with all portions of Chapter 62 of the Government Code, Vernon's Texas Code Annotated.

SOURCE OF NAMES

As stated in Section 62.001 of the Government Code, the source from which the jury wheel shall be constituted is the names of all persons on the current voter registration lists from all the precincts in Terrell County, Texas and the names of all citizens of the County who hold a valid Texas driver's license, and the citizens who hold valid person identification card or certificate issued by the Texas Department of Public Safety, as soon as such information is available from the Secretary of State; provided, however, that the names of persons listed on a register of persons exempt from jury service may not be placed in the jury wheel as provided in the Government code 62.108 and 62.109.

METHOD

Persons called for jury service shall be selected at random with the aid of electronic equipment in a fair, impartial, and objective manner from the source of names required by Section 62.001 of the Government Code, taking into consideration those persons exempt from jury service as provided by Section 62.108 and 62.109 of the Government Code.

OFFICIAL IN CHARGE

The Clerk of the District Courts in Terrell County, Texas is designated as the official to be in charge of the selection process and shall have the duties and authority set forth herein.

DATE OF RECONSTITUTION OF JURY SERVICE

At a time each year, on or before December 31, the jury source shall be reconstituted from the certified list provided by the Secretary of State under the provisions of Section 62.001 of the Government Code.

NOTICE OF JURY SERVICE

The Judges of the District, County, and Justice Courts shall provide in a timely manner to the District Clerk information regarding the required jury panels for the respective courts.

A true and complete written list showing the names and addresses of the persons summoned to begin jury service on a particular date shall be kept by the District Clerk until said list has been used.

A true and complete written list of the names and addresses of persons summoned to begin jury service on a particular date shall be filed with the County Clerk at least ten (10) days before that date.

The District Clerk shall summons by first class mail all persons so listed to be called for jury service on such date at least ten (10) days prior to the date such persons are to begin jury service. The Clerk shall supply the computerized summon forms which shall be addressed to all persons selected.

Any authority or duty assigned to the District Clerk herein may be delegated to a deputy or other designee that the Clerk chooses.

GENERAL JURY PANEL

A District Judge, County Court Judge, or Justice of the Peace may determine the number of prospective jurors that are reasonably necessary for the cases to be tried in their courts. Any District or County Court Judge may act as a Presiding Judge for the jury qualifications and assign such jurors as may be needed to panel the different courts.

ADDITIONAL JURORS

If the presiding judge determines that the number of jurors previously selected for any designated date is insufficient, he shall direct the District Clerk to prepare a supplemental list and summon such additional persons to those already summoned as may be necessary to meet the needs of the courts; provided that such supplemental summons shall be mailed at least ten (10) days prior to the date of service.

AMENDMENTS

This plan may only be amended by the Commissioners' Court of Terrell County, Texas upon recommendation of a majority of the Commissioners of Terrell County, Texas.

EFFECTIVE DATE

This plan shall become effective immediately upon its adoption and approval by the Commissioners' Court.

GENERAL CERTIFICATE

STATE OF TEXAS

COUNTY OF TERRELL

We, the undersigned officers of Terrell County, Texas (the "County"), hereby certify as follows:

- 1. This certificate is executed for an on behalf of the County with reference to the issuance of TERRELL COUNTY, TEXAS, TAX AND REVENUE ANTICIPATION NOTES, SERIES 2023, DATED October 16, 2023 (the "Notes").
- 2. No litigation of any nature has ever been filed pertaining to, affecting or contesting: (a) the Order which authorized the Notes; (b) the issuance, delivery, payment, security, or validity of the Notes; (c) authority of the governing body and the officers of the County to issue, execute, and deliver the Notes; (d) the validity of the legal existence of the County; (e) the current tax rolls of the County; or (f) the levy and collection of taxes, or revenues, by the County.
- 3. The County has no current debt outstanding. The true and correct schedule showing the annual debt service requirements of the proposed Notes is set forth in Exhibit A hereto.

- 4. The currently effective ad valorem Tax Rolls of Terrell County are those for the year 2023, being the most recently approved Tax Rolls of the County; that the taxable property in the County has been assessed as required by law; that the Tax Assessor of the County has duly verified the aforesaid Tax Rolls, and that the assessed value of taxable property in the County upon which the annual ad valorem tax of the County has been levied (after deducting the amount of all exemptions, if any, taken or required to be given under the Constitution and laws of the State of Texas), according to the aforesaid Tax Rolls for said year, as delivered to the County Clerk, and finally approved and recorded by the Commissioner's Court of the County, is no less than \$1,940,836.00.
- 5. The current tax rate of the County established for fiscal year 2023 is as follows per \$100 valuation:

1. County General fund

\$.6331 on the \$100 valuation

The County anticipates no increase in property tax rates will be required to pay principal and interest on the Notes as the same become due. (There will be no additional levy of taxes while the Notes are outstanding. Notwithstanding the foregoing, Terrell County may increase its ad valorem taxes, if the voters of the County approve a Tax Rate Increase at an election held for that purpose.)

The County's collection rate for property taxes for the most recent three fiscal years is as follows:

- 6. The Notes will be used to pay operating or current expenses of the County as permitted by Section 1431 .004(02) of the Texas Government Code for the current 2023/2024 fiscal year. The anticipated revenues and taxes anticipated by the County to be collected during this same fiscal year are no less than \$1,940,836.00. The principal amount of the Notes, being \$750,000, is less than 50 percent of such anticipated taxes and revenues.
- 7. The **initial draw** to be made from the Notes will be <u>\$TBD</u>, to be used to pay County operating expenses, including payroll expenses on or later than October 20, 2023.
- 8. The operating expenses being paid with the proceeds of the notes are included in the annual budget for the current (2023-2024) fiscal year.
- 9. The County expressly finds and determines that the terms of sale of the Notes were the most advantageous reasonably available as set forth in, and required by, Section 1201.022 of the Texas Government Code.
- 10. The County hereby certifies that the County Clerk signing the Notes and other documents related to the issuance of the Notes was either publicly elected, or was appointed in compliance with Section 82.005 of the Texas Local Government Code.
