Default has occurred in the payment of the Note and in the performance of the obligations of the Deed of Trust. Because of that default, Energy/Land, Inc. Pension Plan, the owner and holder of the Note, has requested Substitute Trustee to sell the Property.

Pension Plan's election to proceed against and sell both the real property and any personal property described in the Deed of Trust in accordance with Energy/Land, Inc. Pension Plan's rights and remedies under the Deed of Trust and section 9.604(a) of the Texas Business and Commerce Code.

For the avoidance of doubt, the Foreclosure Sale will not cover any part of the Property that has been released of public record from the lien and/or security interest of the Deed of Trust by Energy/Land, Inc. Pension Plan. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.


