A quorum of the Terrell County Commissioners Court convened in a Public Hearing on Thursday, March 31, 2022 at 5:05 p.m. in the commissioners courtroom of the Terrell County courthouse, 105 Hackberry Street, Sanderson, Texas. Notices of this meeting were timely posted for at least seventy-two hours preceding the scheduled time of this session.

1.- Call to Order/Invocation -The Hon. Dale Carruthers, Terrell County Judge, called this hearing to order at 5:05 p.m. Commissioner Serna gave the Invocation, followed by the Pledge of Allegiance and Pledge to the Texas Flag.

Other special guests and/ or presenters were: Mr. Carl Esser of Esser & Company Consulting, LLC, he joined this public hearing via remote access/Zoom.

2.- Public Comments of proposed Texas Community Development Block Grant Program. Mr. Esser informed that this public hearing is one of the requirements of the grant award. The Community Development Block Grant is from the Texas Department of Agriculture in the amount of \$1,000,000 for the installation of water improvements and upgrades.

This is a Colonia Construction project designated for areas with low to moderate income families. This project will incur administrative, construction and engineering costs.

Commissioner Sanchez asked when the project is scheduled to commence. Mr. Esser stated that the project has already been initiated with the engineering, survey and design phase and this will be presented to this Court for review. The construction phase of this project will start this year by late

summer.
